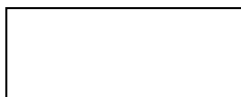

This product contains Ca-Dodecyl benzene sulfonic acid <10% and Alcohol ethoxylate 10-30%.

FIRST AID TREATMENT

Inhalation

Immediately remove from exposure to fresh air. If not breathing give artificial respiration. If breathing is difficult, give oxygen. Obtain medical advice if necessary.

Ingestion

If victim is conscious and alert, give 2 – 4 cupfuls of milk or water. Never give anything by mouth to an unconscious person. Seek medical advice immediately.

Skin Contact

Pre-mix **METHOS** with water and add to the spray mix containing the herbicide.

Add last to the mixing tank after other agrichemicals has been mixed.

Do not use **METHOS** with other adjuvants.
